

Thursday, January 14, 2010 “Costa Rica, Coast to Coast,” by Ralph Geuder. This 14 day bird watching trip included Carara, Cano Negro, Sarapiquí, La Selva and Severgre as well as a side trip to Rancho Naturalista. Club members Jane and Ralph Geuder enjoyed this trip to Costa Rica in February/March of 2009. The trip listed 350 species of birds including 18 species each of raptors and hummingbirds as well as many warblers, tanagers and others. But Costa Rica is not about the numbers...

Thursday, February 11, 2010 “Birding in New Zealand,” by Tom and Geraldine Feild. Tom and Geraldine’s presentation will cover the country’s unique land birds, pelagic birding, the southern hemisphere’s arctic migrants as well as some of New Zealand’s conservation issues. In 2003 when club member Tom Feild left on his “Big Trip” to the southern hemisphere, he found that a Kiwi meant more than just an endemic bird to New Zealand. After five years of “migrations,” one particular “Kiwi” became his wife. Geraldine moved to Howard County in April 2009.



HOW TO FIND AN OWL


Feb. 20, Saturday (1:00 p.m. , possibility of birding till dusk)

GREAT BACKYARD BIRD COUNT

Will you miss the Midwinter Count or do you just want an excuse to do more birding? If so, the Great Backyard Bird Count (GBBC) is for you. The GBBC is sponsored by the National Audubon Society and the Cornell Lab of Ornithology and will be held February 12-15, 2010. Observers count the highest number of each species they see during at least 15 minutes on one or more of the count days. Observers then enter their tallies on the GBBC website, www.birdcount.org.

This count continues to be a huge success. In 2009, history was rewritten with a record number of checklists (93,600) being submitted. Altogether 619 species were seen across North America. Last year, Columbia and Ellicott City led the state with the most checklists submitted; 134 and 110 respectively. You can explore the results of prior years by visiting www.birdcount.org.
