


DO WE HAVE YOUR CORRECT EMAIL ADDRESS?

In late November 2010, the Howard County Bird Club sent an email to all members notifying them that the Recreation and Parks Advisory Board turned down the request from Terrapin Adventures to expand its zipline onto Howard County public park land. 
SEED SALE A SUCCESS BY KEVIN HEFFERNAN

The Howard County Bird Club Seed Sale took place on October 2nd at the Wildlife Authority on US 40 west of Ellicott City. Kevin Cassidy, the owner, went out of his way to make us feel welcome and to make the sale a success. Kevin's staff unloaded the truck and loaded seed into each customer's car making logistics easy for the club. He also provided a discount card for each customer to be used on the day of the sale and another for the first full week in December. The 8695 lbs. of seed sold would have netted \$869.50 for conservation, but Kevin generously rounded the total up to \$1000. The money will be donated to help the birds of the Gulf Coast.

I would like to thank all of our customers for hanging in there with us during the changes that have taken place over the last couple of years. Your support is much appreciated. I would also like to thank Michael O'Sullivan who took all of the orders and worked the desk the day of the sale. Finally, I would like to give a big thank you to Kevin Cassidy and the staff of the Wildlife Authority for their dedication and generosity. This would not have worked without them. If you get a chance, stop in and thank them yourself. They have high quality seed at a great price and a good selection of

Did you miss the Midwinter Count or do you just want an excuse to do more birding? If so, the Great Backyard Bird Count (GBBC) is for you. The GBBC is sponsored by the National Audubon Society and the Cornell Lab of Ornithology and will be held February 18-21, 2011. Observers count the highest number of each species they see during at least 15 minutes on one or more of the count days. Observers then enter their tallies on the GBBC website, www.birdcount.org. 
START YOUR YEAR LIST
