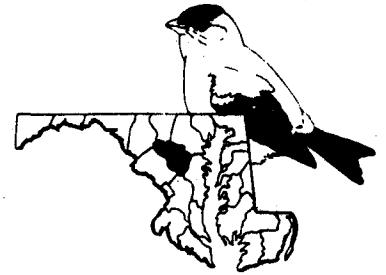

## LETTER FROM THE CHAPTER PRESIDENT



Through the tireless efforts of our previous club presidents and many dedicated volunteers, our club membership has shown a very significant growth over the past few years until we are now approaching 300 members. The times have changed from when it was difficult to find enough people to take on the necessary jobs of the club to the current challenge of providing enough opportunities to match the eagerness of members who want a share in helping us accomplish our reasons for being.

There are three major areas of the club's activities which have each been the responsibility of a single individual: ~~monthly programs, field trips, and conservation.~~ The chairpersons for each of these activities have indicated a willingness to be assisted by other individuals; therefore, we would like to recruit willing people to work on these committees. #### AMPLIFYING SYSTEM PURCHASED BY CHAPTER

An amplifying system has been purchased recently by the chapter to enhance presentations at the monthly programs. Thanks to Rod Botsai and Don Randle for investigating the possibilities and making the purchase. \*

There are wonderful winsome woodpeckers in Howard County. Two species which are often confused are the Downy and Hairy Woodpeckers, both members of the "pied woodpecker" genus--black, heavily mottled with white, small to medium in size. They work hard for their sustenance, living side by side all year round. They are almost identical in color and pattern, differing mainly in size. The male birds have small patches of red on the back of their heads, a mark lacking in the females. The bluebird-sized Downy is slightly more than half the size of the bulkier Hairy. It is this size differential that permits these "sympatric pairs" of species to live together without competing. The smaller birds exploit the smaller tips and outer branches of our trees, while the larger birds glean the main trunks. Both woodpeckers have the characteristic woodpecker flight, four or five rapid flaps, then a swoop downward, followed again by the flapping. Both visit winter feeding stations, although the relatively tame Downy is much the more frequent guest.

But how to tell the difference? There are four clues.

● The Hairy Woodpecker in this area is about the size of a robin. In Garrett County the bird is the size of a Northern Flicker, a rather startling phenomenon. By contrast, the Downy is a midget.

● The bill of the Hairy is long and large, an ideal chisel; however, that of the Downy is a sturdy toothpick, straight but very small. The difference is (excuse the pun) striking.

● The Downy Woodpecker has small black spots on its white outer tail feathers, while the Hairy's retrices remain unspotted. This is a challenging but very definitive field mark. Look for it.

Otherwise, these birds are identical in outward appearance. The behavior of the Downy Woodpecker is predictable and somewhat sedate. On the other hand, the Hairy is very active and excitable; however, it is much shyer than its cousin, and you are much more likely to find it in deeper woods.

● The call note of the Downy is a solid-sounding "peek-ick," short in duration but direct in tone. On the other hand, the Hairy Woodpecker's call is a high-pitched "peek," almost shrill in its quality. The "series notes" of the two birds are also very different. The Downy gives forth a "rapid whinney of notes, descending in pitch." Its tone is high, yet robust. But if, in the midst of a wooded area, you hear short bursts of the kingfisher's rattle, you undoubtedly have uncovered a Hairy Woodpecker. The sound is rapid, metallic, cicada-like.

Downy Woodpeckers are ubiquitous. Hairy Woodpeckers are much less abundant, but this is a good area for them. They are especially common in the Fort Meade area.

## RECYCLING CENTER OPENS IN HOWARD COUNTY - SAVE ITEMS AND RECYCLE THEM

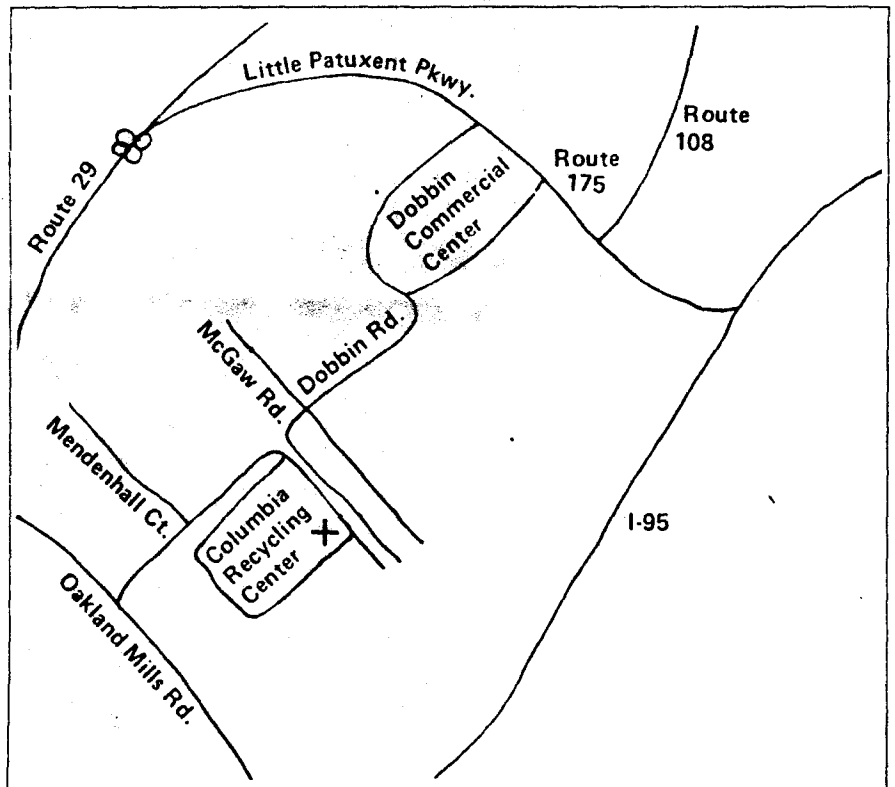
The Columbia Recycling Center has opened recently off Dobbin Road on the east side of Columbia. (See map below for exact location.) The Center is operated by Athelas Institute, Inc., a non-profit organization that provides vocational education and work training programs for mentally retarded adults.

Aluminum can be recycled for cash. Other items accepted include newsprint (no magazines), glass, and bimetal. Items other than aluminum will be credited to any group or club that has registered with Athelas Institute. WE HAVE REGISTERED! Mention either the Howard Bird Club or Howard Chapter MOS as the group to which you want your items credited. Checks will be sent to groups on a quarterly basis. Currently, newsprint is credited at the rate of \$15.00 per ton and glass at \$10.00 per ton. Aluminum has been fluctuating between .25 and .30 per pound. Hours are Monday-Saturday 10:00 a.m.- 2:00 p.m. If you have questions call 992-4234. Most of our members are aware of the advantages of recycling. Now that a center again exists in Howard County, do take advantage of it. If you take items somewhere else for recycling, by all means continue, but help save raw materials, precious landfill space and reduce unsightly litter. **RECYCLE!** (The Center does not accept plastic or metal other than aluminum and bimetal.) Thanks to Monika Botsai for taking care of the registration and letting us know about the Center.

Observations need not be on your property. Include boxes or natural cavities in your neighborhood or elsewhere in the county if you know no one else will be reporting them. Do not include boxes located in county parks or which are part of an organized trail unless you are the operator of that trail or have permission from the operator to tally certain boxes separately. If you know a cavity or box was occupied, but do not know the number of young fledged put a question mark in the appropriate blank. If young were lost from boxes due to predators, vandals, weather, etc., list reasons for losses in descending order of importance

For trail operators: Number of boxes on trail \_\_\_\_\_

Do not tally European Starlings & House Sparrows. They are not protected by law. Make every effort to prevent their nesting in your boxes, buildings, or natural cavities.

#### NATURE CONSERVANCY BIRDATHON COUNTERS FIND 194 SPECIES

Those Howard members who attended the April meeting recall that Chandler Robbins described a birdathon planned for early May to raise funds for the Maryland Natural Areas Campaign of the Nature Conservancy. A 24-hour count on May 10th by Chandler Robbins, Hal Wierenga and Byron Swift tallied 194 species in central Maryland and coastal Virginia. Areas along the C & O Canal, Hughes Hollow, the fish hatchery at Lilypons, New Design Road, and Sugarloaf Mountain were visited in central Maryland. A donated plane ride to Wallops Island and birding on Chincoteague NWR and along Elliott Island road completed the day. The Birdathon was organized by Bob Whitcomb, 10610 Belfast Pl., Potomac, MD 20854, who would be delighted to receive any pledge sheets and checks not yet turned in.
